## Jumper Rules

Adult supervision at all times. No fighting or wrestling allowed. No "Silly String", gum, candy, balloons, shoes or any other objects are allowed inside of the jumpers. Please no jumping against the walls or hanging from the nets. If disinflation occurs everyone must exit the Jumper immediately. If rain occurs during rental have all persons exit then turn the blower motor off and wait for the weather to subside.

## Term and Condition

- EQUIPMENT, RENT & TERM OF RENTAL AGREEMENT. The Undersigned, as lessee from Gemelli Inc. DBA Bounce Mania and Party Rentals, as lessor, one inflatable unit, Identification Number: \_\_\_\_\_ Blower ID Number \_\_\_\_\_. The Rental Fee as stated payable.
- SPECIAL INSTRUCTIONS: The inflatable unit's equipment is reliable, should the inflatable unit begin to deflate 1) the motor has stopped in which case check the cord connection at the outlet near the motor and remember to keep only the 50 foot extension cord on the outlet. (Stronger outlets are in the kitchen and laundry rooms). 2) If the motor is continuing to run, check the air intake on the side of the motor for blockage and check both tubes at the back of the inflatable unit for snugness, retie if necessary, 3) IF YOU CANNOT CORRECT THE PROBLEM CALL 817-791-2675
- GENERAL RULES TO FOLLOW DURING THE USE OF THE INFLATABLE UNIT:
  - Only compatible age groups and size play in the inflatable unit at the same time. The maximum number of people of each group that should play in the unit at a time is:

  - All riders MUST REMOVE THEIR SHOES before, playing in the inflatable unit.
  - To avoid neck and back injuries, FLIPS ARE NOT ALLOWED.
  - CHILDRENS SAFETY DEPENDS UPON YOU. YOUR PERSONAL SUPERVISION IS ABSOLUTELY REQUIRED. AS THE LESSEE OF THE INFLATABLE UNIT, THE SAFETY OF ALL CHILDREN IS YOUR RESPONSIBILITY.
  - Absolutely NO water, "Silly String", gum, candy, food or other sticky substances aren't allowed in the inflatable unit. If upon pick up such cleaning is required then a \$50.00 cleaning fee shall be automatically imposed. \_\_\_\_\_ (INITIAL).
  - DO NOT MOVE the inflatable from the place where it was installed. If the inflatable unit moves, pull the corner back to its original location of installation. Keep the inflatable unit away from swimming pools.
  - Absolutely no pets inside the inflatable unit. Boys or Girls with long hair should tie their hair, before entering the unit.
- DELIVERY To the street address specified above by the Lessee (Customer). Lessee grants Lessor right to enter the Property at the said street address. ("Delivery Address") for the delivery and subsequent pick up of the inflatable unit at the specified time.
- TRANSPORTATION EXPENSE Except as provided herein, all charges in delivering and subsequent pick-up of the inflatable unit with respect to the Delivery Address are included in the Rental Fee noted above. In the event that the inflatable unit is not at the appointed time by the lessee, then a \$50.00 extra transportation fee shall be automatically imposed. \_\_\_\_\_ (INITIAL).
- SAFE OPERATION ACKNOWLEDGMENT: LESSEE ACKNOWLEDGES THAT HE/SHE HAS BEEN INSTRUCTED ABOUT AND FULLY UNDERSTANDS THE SAFE OPERATION OF THE INFLATABLE UNIT, WHICH IS THE SUBJECT OF THE RENTAL AGREEMENT AND LESSEE AGREES TO OBSERVE ALL SAFETY PRECAUTIONS. LESSEE ALSO WILL BE HELD LIABLE UP TO TEN THOUSAND DOLLARS IF THE INFLATABLE UNIT IS NOT RETURNED IN THE ORIGINAL CONDITION
- MAINTENANCE: Lessee agrees to keep the inflatable unit in the same condition as when received, ordinary wear is expected.
- ALTERATION AND ATTACHMENT: No alteration in or attachments to the inflatable unit can be made without prior written approval of Lessor.
- WARRANTY: Lessor warrants that the inflatable unit leased under this Rental Agreement will be in good working order on the effective date of the Rental Agreement. The inflatable unit is supplied and maintained subject to this warranty. Lessor's obligation under the Rental Agreement is limited to repair or replacement of the inflatable unit when Lessor determines that it does not conform to this warranty. This warranty is in lieu of any and all other warranties expressed or implied, and all liabilities on the part of the Lessor for the damages including, but not limited to consequential damages, arising out of or in connection with the use or performance of the inflatable unit.
- ENTIRE AGREEMENT: The Rental Agreement constitutes the full agreement between Lessor and Lessee. Time is of the essence of this Rental Agreement. Lessee acknowledges that the inflatable is subject to the Rental Agreement.
- RELEASE OF LIABILITY: The lessee shall be in charge of inflatable unit's operation, as well as return of the inflatable unit in good working order. Further the Lessee can not hold Lessor including all the officers, employees and agents for any kind of injury or claims. The Lessee shall identify the lessor and its officers, employees and agents for any kind of injury or claim. The Lessee shall identify the Lessor and its officers, employees and agents from against any costs incurred due to claims from anyone including attorney's fees and related costs involving the use of inflatable unit should legal action become necessary.
- TITLE TO BOUNCE MANIA AND PARTY RENTAL: Lessee agrees to keep the inflatable unit in his/her custody and not sublease, rent, sell or remove from the Delivery Address, or otherwise transfer such inflatable unit. The inflatable will remain at the property of the Lessor and may be removed by Lessor at any time after the termination of this Rental Agreement. THE SAME DRIVER WILL COME TO PICK-UP THE INFLATABLE
